MEI-2017/CR-50/Desk-5 dated 30/01/2018 has recognized as Hindustani Education Society Ausa as Islam/Religion and Urdu/Linguistic minority education institution under the section 2 (g) of the National Commission for Minority Education Institutions Act 2004.
