### **Think tank behind perspective plan: IQAC**

According to UGC: Maintaining the momentum of quality consciousness is crucial in colleges. Internal Quality Assurance cell, in fact, is conceived as a mechanism to build and ensure a quality culture at the institutional level. Every college should have an internal Quality Assurance system, with appropriate structure and processes, and with



enough flexibility to meet the diverse needs of the stakeholders. The internal quality assurance mechanism of the institution may be called "Internal Quality Assurance Cell (IQAC)". The IQAC is meant for planning guiding and monitoring Quality Assurance (QA) and Quality Enhancement (QE) activities of the colleges. The IQAC may channelize and systematise the efforts and measures of an institution towards academy excellence. It should not be yet another hierarchical structure or record-keeping exercise in the institution; it would be a facilitative and participative organ of the institution. Following the guidance of UGC and NAAC office, college established its IQAC in 2012. 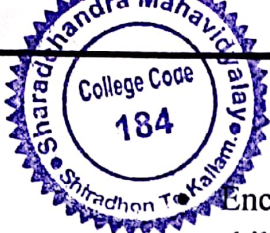
- Motivate staff to publish their research in UGC Care list.
