POLICIES:

According to the UGC Regulation on Curbing the Menace of Ragging in Higher Institutions, 2014, ragging constitutes any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student. It assumes and functions as:

- Ragging is a humiliating social crime.
- To prevent and protect the student community from being ragged or indulging in the act of ragging.
- To bring awareness among the students about the ill effects of ragging, its impact on human life and consequences of involvement in the act of ragging.
- To set up a monitoring system comprising of Anti Ragging Squad to vigil the on campus and off campus situations to eliminate the chances of ragging cases.
- To receive the complaints and resolve them through the Committee.
- To initiate legal actions when required considering the intensity of ragging instances in case occur.
