Agenda 10: Giving each student a separate topic for research project report.



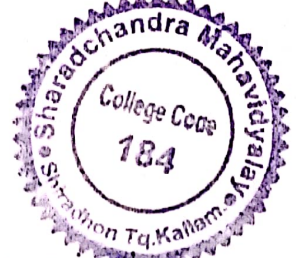
