The parameters used made it possible to evaluate the curriculum's general and discipline-specific features.

> In the academic year 2020-2021, 'Students Feedback Form on Curriculum' is collected by the departments of English, Hindi, Marathi, Urdu, Geography, Library & Information Science, History, Economics, Political Science, Sociology and Sports from their students. Approximately 201 students participated in filling the form. 'Teachers Feedback Form' is collected from the various college teachers in the jurisdiction of the university by the subject departments. Approximately 20 teachers participated in filling the form. 'Employers Feedback Form' is collected from the various wholesale shop owners, businessmen, industry, dealers, etc. by the college feedback committee. Approximately 10 employers participated in filling the form. 'Alumni Feedback Form' is collected from the successful students of our college. Approximately 20 alumni participated in filling the form.

Action Taken Report on Feedback 2020-2021

The findings from the analysis of stakeholder feedback on curriculum have been communicated to the Management, CDC and IQAC. Besides following actions were taken –
