

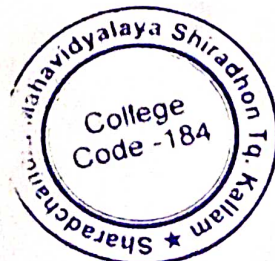
A meeting of IQAC with feedback committee was held on 05/04/2019 to discuss the modalities for collection and analysis of feedback from different stakeholders.


