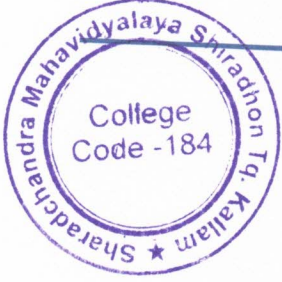

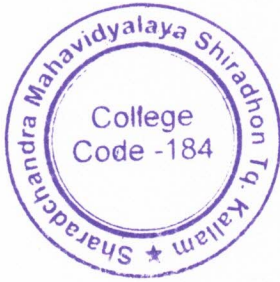

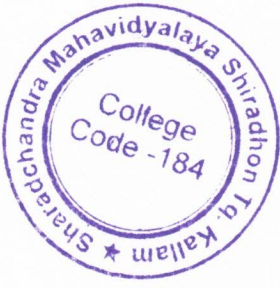

5.2.1 Percentage of placement of outgoing students and students progressing to higher education during the last five years



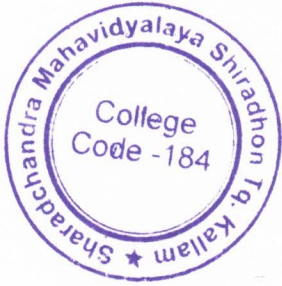

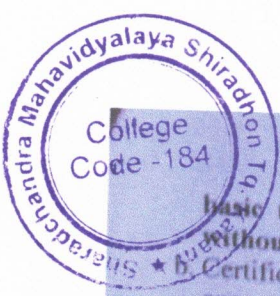
- iii. You will be on probation for a period of two years.
